<b>Who can use this form?</b>	People with Medicare who want to join a Medicare Advantage Plan
<b>To join a plan, you must:</b>	<ul style="list-style-type: none"> <li>• Be a United States citizen or be lawfully present in the United States.</li> <li>• Live in the plan's service area.</li> </ul> <p><b>Important:</b> To join a Medicare Advantage Plan, you must also have both:</p> <ul style="list-style-type: none"> <li>• Medicare Part A (hospital insurance).</li> <li>• Medicare Part B (medical insurance).</li> </ul>
<b>When do I use this form?</b>	<p>You can join a plan:</p> <ul style="list-style-type: none"> <li>• Between October 15 – December 7 each year (for coverage starting January 1).</li> <li>• Within three months of first getting Medicare.</li> <li>• In certain situations where you're allowed to join or switch plans.</li> </ul> <p>Visit <a href="http://www.medicare.gov">www.medicare.gov</a> to learn more about when you can sign up for a plan.</p>
<b>What do I need to complete this form?</b>	<ul style="list-style-type: none"> <li>• Your Medicare number (the number on your red, white, and blue Medicare card).</li> <li>• Your permanent address and phone number.</li> </ul> <p><b>Note:</b> You must complete all items in section 1. The items in section 2 are optional — you can't be denied coverage because you don't fill them out.</p>
<b>Reminders:</b>	<ul style="list-style-type: none"> <li>• If you want to join a plan during fall open enrollment (October 15 – December 7), the plan must get your completed form by December 7.</li> <li>• Your plan will send you a bill for the plan's premium.
