

Controlling Blood Pressure Claims Coding Chart

The HEDIS® measure for Controlling Blood Pressure (CBP) can be reported using CPT II codes. Below are the CPT II codes that correspond to particular systolic and diastolic blood pressure measurements.

Code	Type	Measure	Description
3074F	CPT II	Controlling Blood Pressure	Most recent systolic blood pressure less than 130 mm Hg
3075F	CPT II	Controlling Blood Pressure	Most recent systolic blood pressure 130-139 mm Hg
3077F	CPT II	Controlling Blood Pressure	Most recent systolic blood pressure greater than or equal to 140 mm Hg
3078F	CPT II	Controlling Blood Pressure	Most recent diastolic blood pressure less than 80 mm Hg
3079F	CPT II	Controlling Blood Pressure	Most recent diastolic blood pressure 80-89 mm Hg
3080F	CPT II	Controlling Blood Pressure	Most recent diastolic blood pressure greater than or equal to 90 mm Hg

Comprehensive Diabetes Care Hemoglobin A1c Claims Coding Chart

The HEDIS® measure for Comprehensive Diabetes Care (CDC), which includes Hemoglobin A1c (HbA1c) testing and results, can be reported using CPT and CPT II codes. Below are the codes that correspond to the testing and results measurements.

Code	Type	Measure	Description
83036	CPT	Comprehensive Diabetes Care	Hemoglobin; glycosylated (A1C) test
83037	CPT	Comprehensive Diabetes Care	Hemoglobin; glycosylated (A1C) test by device cleared by FDA for home use
3044F	CPT II	Comprehensive Diabetes Care	Most recent HbA1c is less than 7.0
3046F	CPT II	Comprehensive Diabetes Care	Most recent HbA1c is greater than 9.0
3051F	CPT II	Comprehensive Diabetes Care	Most recent HbA1c is 7.0-7.9 (less than 8.0)
3052F	CPT II	Comprehensive Diabetes Care	Most recent HbA1c is 8.0–less than or equal to 9.0

Medication Reconciliation Post-Discharge Claims Coding Chart

Medication reconciliation post-discharge is an important part of safe transitions of care and helps reduce unnecessary hospital readmissions. The Centers for Medicare and Medicaid Services (CMS) adopted the Medication Reconciliation Post Discharge (MRP) HEDIS® guidelines to measure certain performance goals. The HEDIS® guidelines identify four CPT codes associated with this measure that can be submitted.

Code	Type	Measure	Description
1111F	CPT II	Medication reconciliation post-discharge	Medication reconciliation post-discharge within 30 days
99483	CPT	Medication reconciliation post-discharge	Medication reconciliation and review for high-risk medications, if applicable
99495	CPT	Medication reconciliation post-discharge	Transition Care Management for patients seen within 14 days of discharge
99496	CPT	Medication reconciliation post-discharge	Transition Care Management for patients seen within 7 days of discharge

Please note, correct coding and submission of claims is the responsibility of the submitting provider. Submitting the correct CPT code helps inform us that you have provided the service, and may decrease the need for us to request medical records to review for this information.
