These factors may supplement, modify, or in some cases supersede reimbursement policies.*

*This reimbursement policy applies to all health care services billed on a CMS-1500 form or its electronic equivalent, or when billed on a UB-04 form or its electronic equivalent.*

## Policy Overview

This policy addresses the mandatory National Drug Code (NDC) requirements for both professional and outpatient facility drug claims when submitted for reimbursement. National Drug Code numbers are industry standard identifiers for medications; the NDC number identifies the manufacturer, drug name, dosage, strength, package size and quantity.

## Reimbursement Guidelines

First Choice VIP Care requires a valid NDC number, NDC unit of measure and NDC units dispensed for the drug administered for reimbursement on professional and facility claims. If the NDC number is missing, invalid, or does not match the HCPCS or CPT code submitted, the claim will not be eligible for reimbursement. Note the NDC must also be active for the date of service.

NDC Unit of Measure (UOM)

UOM	Description
GR	Gram
ML	Milliliter
F2	International unit
UN	Unit

The units submitted for a drug should not exceed the package maximum units, based on the NDC number or in increments associated with the drug package. Any amount that surpasses the maximum units on the package will not be eligible for reimbursement.

## Definitions

### National Drug Code (NDC)

The National Drug Code (NDC) is a unique 10- or 11-digit number that identifies a drug's labeler, product, and package size. It's used to report drugs to the FDA and is required for all prescription and non-prescription medications in the United States.
